Arcep launches a broad public consultation to plan for the future of mobile networks and their regulation

Paris, 23 May 2022

Users' connectivity demands, growing and changing digital uses, technological shifts and evolving frequency requirement, new players, societal expectations and environmental imperatives... these are the issues and challenges facing the mobile network sector today. As the sector's regulator, Arcep is committed to keeping pace with these changes, and to making them part of its ongoing pursuit of regulatory objectives. To this end, it is launching a public consultation that will run until 23 September 2022.

Operators, equipment suppliers, but also associations, local authorities, businesses, academics and concerned citizens... are all invited to contribute to all or part of the public consultation

The public consultation includes four entries:

- Future uses, new connectivity and use case expectations: can 5G satisfy these expectations, what frequencies and technologies are best suited meet coverage expectations, what changes in network architecture are likely?
- Businesses and industrial players' specific connectivity needs: what technologies, network architectures and business models are best suited to match expectations?
- Societal and environmental imperatives: what are they and how to incorporate them into the obligations imposed on operators in the terms of their frequency licences?
- Questions specific to the different frequency bands, and their future use.

The contributions received will help inform Arcep's short, medium and long-term work on spectrum management, and on defining the award procedure for frequencies that are or will become available.

Arcep will host a series of webinars to present the issues covered by this broad consultation to the different categories of stakeholder

Several webinars will be held on this public consultation, to give Arcep an opportunity to present the consultation document and answer stakeholders' questions. Four webinars thus will be hosted in June, each one for a specific target audience:

- 14 June at 10 am for local and territorial authorities;
- 14 June at 4:00 pm, for associations concerned about the digital carbon footprint;
- 16 June at 4:30 pm, for industry players and startups;
- 17 June at 10 am, for consumer and trade associations.

Broadening the scope of the public consultation beyond players who are familiar with Arcep

This public consultation is aimed at a very broad audience, beyond those stakeholders who are already familiar with Arcep's actions. ASSOCIATIONS AND CITIZENS WORKING TO REDUCE THE DIGITAL CARBON FOOTPRINT

The future of mobile networks and the digital carbon footprint: associations and concerned citizens, Arcep wants to hear from you!

The carbon footprint, consumption of rare earths, water, primary energy... the environmental impact of communication networks, devices and ICT is a growing source of concern. Arcep (the Regulatory Authority for Electronic Communications, Postal Affairs and Print Media Distribution) has made the environment a new central focus of its regulation, notably through its "Achieving digital sustainability" collaborative platform. Today, it is publishing a public consultation on the future of mobile networks, which includes an environmental dimension. Associations and concerned citizens are invited to respond to this consultation which will run until 23 September 2022. Part 3.2 in particular gives everyone an opportunity to help deepen Arcep's examination of ways to reduce the environmental impact of networks, and to promote digital sustainability in general.

In particular, you could share your views and findings on the new functionalities, use cases and architectures to emerge from 5G in Part 1 of the consultation. Questions regarding societal needs in the areas of mobile coverage and quality of service, as well as environmental issues are in Part 3.
