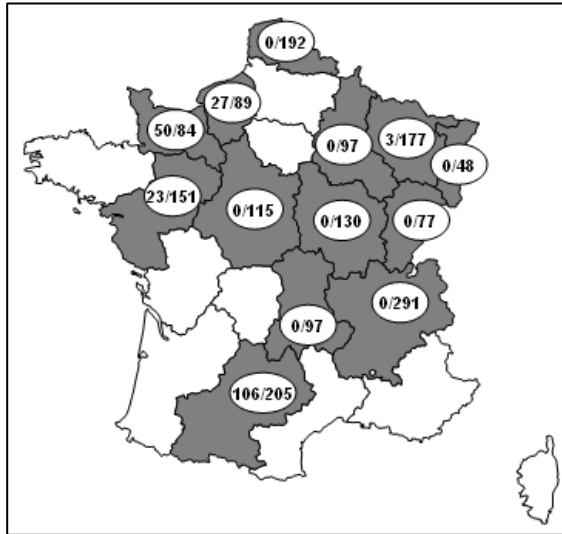

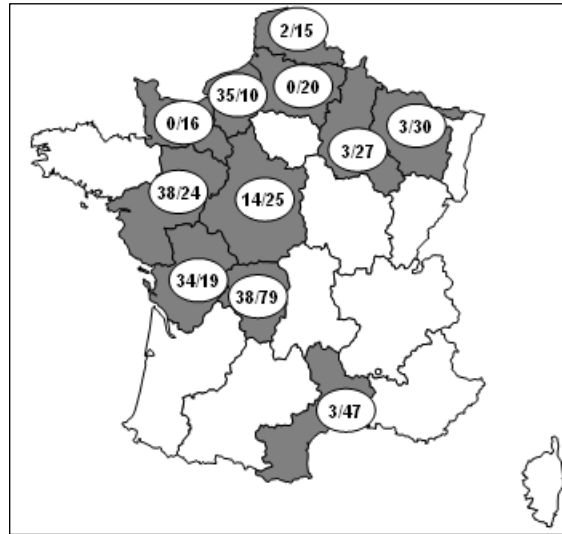

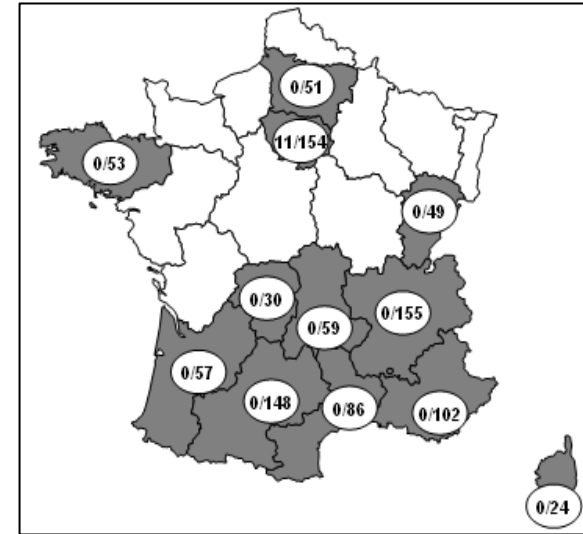
Sites installed/obligations



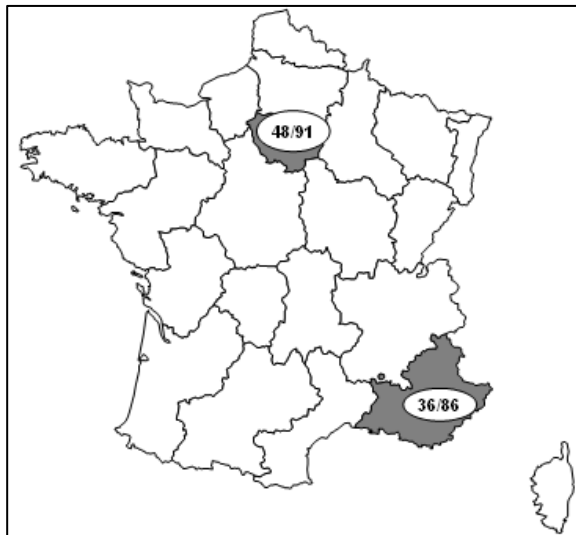

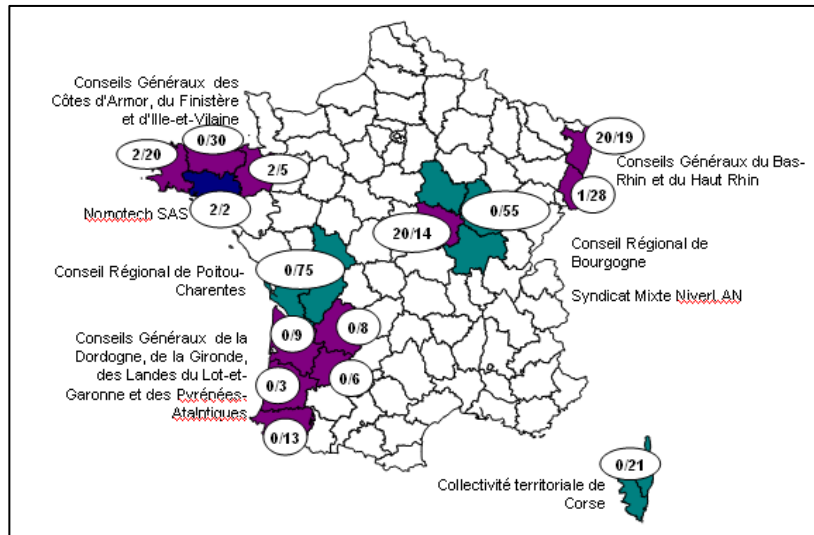
